JUDGES AND JURIES	All judges must have a current valid FIG brevet at the time of the event, for the respective discipline (TRA). Judges from German clubs need the national A - license All participating delegations have to provide 1 judge.
REGISTRATION DEADLINES	 The nominative registration must be made exclusively online via the GymCity Open website www.gymcity-open.de. It is possible to register from the 15th of July 2024. All members of the delegation that attend the competition (athletes, coaches, judges) have to be registered. Nominative registration 1st September 2024 Penalty for missing judge or late registration 35€ per participant of the team. All additional services such as accommodation, banquet and transfer service can be booked by the nominative registration. All coming delegation will be informed through an email.
ENTRY FEES	The entry fee for this event will be 35€ per person and 35€ for each synchronized pair. Entry fees are non-refundable in case of cancellation.
ACCREDITATION	 The accreditation is on Friday 25th September 2024 at 04.00pm in the local organisation office. Heads of the delegations are required to bring the following documents: Passport/any ID of all members of the delegation Proof of total payments Proof of medical insurances International/national judge licenses

EVENT FORMAT	In addition, the host Club SC Cottbus Turnen e.V. is allowed to set up one gymnast per category in every final. If there is no athlete from home club in the final there will be nine (9) starters in the final (Cottbus club Wildcard).	
	In competition there will be no "one- touch" instead every category becomes 20 minutes of warming up. In the finals there will be 10 minutes warming up time.

The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.	
	The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.	
LOCAL TRANSPORTATION	The local transportation from the airports (Berlin, Dresden) or railway station and between the hotel and venue will cost 50€ (per delegation member) and must be ordered.	











COVID-19	All Federations / clubs are invited to take information about special requirements and restrictions to enter Germany for their respective countries. In due time the LOC will provide all participating delegations a detailed Covid-19 guidelines. FIG requires all participants, judges and officials to take standard precautionary measures, such as washing their hands and using a mask at all times and, when possible, to keep a physical distance of at least 1.5 meters. The only situation in which it is possible that the safety distance may not be respected is when the coach assists the gymnast during their performances (catching, directing, guarding). This phase should be as short as possible and the person assisting is obliged to use a mask during this time
